POOL AREA RULES

- 1. Koa Resort does not accept any responsibility for injuries or damages sustained by the users of the pool, jacuzzi or pool area.
- 2. Pool area hours are from 9 AM until 9 PM daily. This includes the pool, jacuzzi and shuffleboard area.
- Owners and residents are permitted a reasonable number of non-resident guests who must be accompanied by the owner or resident when using the pool area. REASONABLE NUMBER IS DEFINED AS NOT MORE THAN 5 PERSONS.
- 4. Children under the age of 12 must be accompanied by a responsible adult.
- 5. No running, jumping or diving off the pool bridge will be permitted. Violation of this rule can result in loss of pool privileges.
- 6. Rubber rafts, surf boards, diving equipment or metal articles or other items which may cause damage to the filter system or pool are not allowed. Swimming aids for young children are permitted. No water toys are permitted in the jacuzzi at any time. Small children should not use the jacuzzi unattended.
- 7. Litter, cigarettes, etc. must be disposed of in the receptacles provided.
- 8. No glass containers of any kind shall be allowed in the pool area. ONLY PLASTIC GLASSES. No picnic items such as coolers, paper plates, etc. are allowed in pool area.
- 9. Pool furniture shall not be removed from the pool area at any time.
- Shuffleboard equipment must not be removed from the shuffleboard court area and shall be used only for the purpose of playing the game. Equipment shall be properly returned to storage stand by user.
- 11. The swimming pool gates are to remain locked at all times. HOLDING THE GATES IN AN UNLOCKED POSITION THROUGH THE USE OF AN OBSTACLE PREVENTING LATCH CLOSURE IS STRICTLY PROHIBITED.
- 12. Parents are responsible for their children's access to and from the pool area at all times.
- 13. Children's toys, other than small water toys, are not permitted inside pool gates.
- 14. FOR HEALTH AND SAFETY REASONS, AND IN CONSIDERATION OF GUESTS, BABIES ARE NOT PERMITTED IN THE JACUZZI AND SHOULD NOT BE TAKEN IN THE POOL WITHOUT ADEQUATE PROTECTION SUCH AS SNUG FITTING PLASTIC PANTS.
- 15. THE MANAGER WILL ENFORCE THE HOUSE RULES AND SWIMMING POOL AREA RULES. THE MANAGER IS AUTHORIZED TO TAKE ANY ACTION NECESSARY FOR THE SAFETY, SECURITY AND PROTECTION OF ALL OCCUPANTS AND PROPERTY, INCLUDING USE OF LAW ENFORCEMENT PERSONNEL.
